CURRENT VENDOR AND RENTAL INFORMATION

- Standard vendor space: \$100 per approved event unless a different amount is stated in the event announcement. Space is limited and placement is not guaranteed until approved and paid.
- Optional radio/podcast promotional add-on: \$25 when offered for the event.
- Private Soul Lounge 2.0 rental: \$75 per hour, one-hour minimum. Examples: 2 hours \$150; 3 hours \$225; 4 hours \$300; 6 hours \$450.
- Whole-day venue package: 10:00 a.m. to 12:00 midnight for \$750. Standard 14-hour value is \$1,050, giving a \$300 package savings.
- Venue overtime is \$37.50 per 30-minute increment and requires approval. DJ services are separate and require a written quote.

PAYMENT & RESERVATION

Venue rentals require a 50% nonrefundable reservation payment. The remaining balance is due seven calendar days before the event. Setup, event time, cleanup, and removal are included in paid time.

MANDATORY EVENT RULES

- Renter/vendor is responsible for guests, vendors, safety, permits, legal alcohol service, occupancy, parking, noise, fire-code compliance, and staff instructions.
- Cleanup is part of paid time. Remove property and decorations, bag trash, wipe surfaces, clean spills, sweep debris, and return furniture to its original location before departure.
- No unlawful activity, weapons, fighting, smoking/vaping indoors, open flames, glitter, confetti, permanent adhesives, nails, screws, or alterations without written approval.
- Excessive cleaning, damage, missing property, unauthorized overtime, or lockout service may be billed after the event.
